EVENT RULES & PARTICIPANT AGREEMENT

By signing below, I acknowledge and agree to the following:

General Event Rules

- This is a rain-or-shine event.
 - Open to all runners and walkers - with or without dogs
 - All dogs must always remain leashed.
 - Leashes may not exceed 6 feet.
 - No retractable or flexi leashes permitted.
 - No head collars (Halti, Gentle Leader).
 - Muzzles are allowed only if they permit full panting.
 - Proof of Rabies Vaccination. Must be shown at time of registration.
 - No dog-to-dog greetings. We have a "No Greet" Policy. (Please see below).
 - Owners are responsible for their dog's behavior at all times.
 - Participants must ask permission before approaching any dog.
 - Owners must clean up after their dogs. (Bring waste bags).
 - Event organizers reserve the right to remove any participant or dog displaying unsafe or aggressive behavior.

Competitive Canicross Division Rules (If Applicable)

- Dog must wear a proper canicross harness.
- Runner must use a hands-free waist belt for the runner and bungee line connecting dog to runner.
- Only one dog per runner.

- Dogs must run ahead of or alongside handlers, never behind.
 - 90-minute time limit for award eligibility. All competitors must complete trail. Failure to do so will result in scratch or disqualification.
 - Failure to follow equipment or conduct rules may result in disqualification.

"No Greet" Policy & Safety Reminders

Although this race is a dog friendly event, we have a "NO GREET" POLICY! Dogs must be always leashed and under control in the parking lot and event area. Dogs should NOT interact with other dogs while attending our event. Please advocate for your dog and their needs especially around the starting/ finishing chute and when passing on course. MUZZLES are allowed and can be worn on course if the dog has ample room for panting.

LIABILITY WAIVER AND RELEASE PET OWNER

READ THIS DOCUMENT CAREFULLY. BY SIGNING THIS DOCUMENT, YOU WILL WAIVE LEGAL RIGHTS INCLUDING THE RIGHT TO SUE.

I, the undersigned, wish to have my pet dog participate in "Tails on the Trail 5K & Canicross Event. (hereinafter, "Activity") with Pet Central, LLC. (hereinafter, "Company"). I wish to participate in the Activity with or without my pet and hereby assume all risks of engaging in the Activity, including by way of example and not limited to, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them, or because of their possible liability without fault. In consideration of my taking part in the Activity, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors and assigns as follows:

(a) I WAIVE, RELEASE AND DISCHARGE from any and all liability, including but not limited to liability arising from (1) the negligence or fault of the entities or persons released, (2) the intentional, reckless or negligent conduct of any participant, or (3) any defect in the equipment provided by the Company for my pet's death, disability, injury, loss, or actions of any kind which may hereafter occur to my pets or myself including my traveling to and from the Activity and at all time throughout, THE FOLLOWING PERSONS AND ENTITIES: Chanda R. Brewer and Pet Central, LLC and/or their employees, volunteers, independent contractors, representatives, agents, heirs, successors, assigns and any sponsors and volunteers;

(b) INDEMNIFY, HOLD HARMLESS AND PROMISE NOT TO SUE the entities or persons mentioned above from any and all liabilities, claims, demands, costs, losses, expenses or compensation of whatever nature, including attorney's fees, for loss, damage or injuries to persons or property sustained by me, my heirs, personal representatives, successors and assigns and all other persons, resulting from or in any way connected to my participation in this Activity, including but not limited to travel to and from the location of the Activity and at all time throughout, whether directly or indirectly caused by (1) the negligence of the entities or persons released, (2) the intentional, reckless or negligent conduct of any participant, or (3) any defect in the equipment provided by the Company.

I acknowledge that this Activity can be hazardous and carries with it the potential for my dog's death, serious injury and loss. The risks include, but are not limited to, those caused by weather, temperature, terrain, condition of participants, equipment, vehicular and waterway traffic and actions of other people including, but not limited to, participants, employees and volunteers involved with the Activity. These risks are not only inherent to the participants but are also present for those involved with the Company. As a specific condition of my participation in the Activity, I expressly assume all risks involved, including but not limited to those risks that are unforeseen. I acknowledge that the above entities or persons are NOT liable for the death, injuries or loss of my dog and are NOT responsible for the errors, omissions, acts or failures to act of any participant or party or entity conducting a specific activity on their behalf. This Liability Waiver and Release shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. This Liability Waiver and Release constitute the entire agreement between the parties. I understand that participation in a running event with dogs involves inherent risks, including but not limited to falls, collisions, animal behavior, and weather-related conditions. I voluntarily assume all risks associated with participation and release Pet Central, Clearwater County Humane Society, event volunteers, sponsors, and the City of Bagley from liability for any injury, loss, or damage arising from participation. I certify that I am physically able to participate and that my dog is healthy and fit for this event. I grant permission for event organizers to use photographs or video taken during the event for promotional purposes. I CERTIFY THAT I HAVE READ THIS DOCUMENT IN ITS ENTIRETY AND I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT AND I SIGN IT OF MY OWN FREE WILL.
